- **3.** Technical proposals will be opened on the same day on **16 June**, **2022 at 10:30 am** in presence of bidders or their authorized representatives who wish to witness the tender opening. After the technical evaluation, financial proposals of only technically qualified bidders shall be open on a date/time to be announced subsequently.
- **4.** The Bid Security equal to 2% (two percent) of the Estimated Price must be attached with the **Technical Proposal** preferably in the form of Bank Guarantee or Pay Order or CDR in favor of **"Punjab Cattle Market Management & Development Company".**
- **5.** The financial proposal shall be inclusive of all applicable taxes.
- **6.** Affidavit on Rs.100/- e-stamp paper, duly attested by Oath Commissioner, that the company has never been blacklisted by any Government/Semi Government/autonomous body or private organization.
