2. Technical and financial proposals should be submitted in separate envelopes. The word "Technical Proposal" and "Financial Proposal" being clearly written on the top left corner of the respective envelopes.
3. Technical proposals will be opened on the same day **17th June, 2020 at 10:30 am** in presence of bidders or their authorized representatives who wish to witness the bid opening. After the technical evaluation, financial proposals of only technically qualified companies shall be opened on a date/time to be announced subsequently.
4. The bid security equal to 2% (two percent) of the total estimated price must be attached with the financial proposal in the form of Pay Order/CDR/Demand Draft in favor of "Lahore Division Cattle Market Management Company".
5. The Financial Proposal shall be inclusive of all applicable taxes (Income tax, GST etc.).
6. Affidavit on stamp paper that the company has never been blacklist by any Government/Semi Government/Autonomous body or private company.
