- 2. Technical and financial proposals should be submitted in separate envelopes. The word "Technical Proposal" and "Financial Proposal" being clearly written on the respective envelopes.
- 3. Technical proposals will be opened on the same day 17 December, 2020 till 10:30 am in presence of bidders or their authorized representatives who wish to witness the tender opening. After the technical evaluation, financial proposals of only technically qualified bidders shall be open on a date/time to be announced subsequently.
- 4. The Bid Security equal to 2% (two percent) of the Estimated Price must be attached with the **Technical Proposal** in the form of Bank Guarantee (In response of Circular No. L&M(PPRA) 10-1/2011 uploaded on PPRA website dated Jul 29, 2020) in favor of "**Punjab Cattle Market Management & Development Company**".
- 5. The Financial Proposal shall be inclusive of all applicable taxes.
- 6. Affidavit on Rs.100/- stamp that the company has never been blacklist by any Government/Semi Government/autonomous body or private company.
- 7. The companies/ firms/ sole proprietors must have valid Registration Certificate for Income Tax (NTN) & STRN.
- 8. Incomplete Proposals shall not be considered.
