2. Technical and financial proposals should be submitted in separate envelopes. The word "Technical Proposal" and "Financial Proposal" being clearly written on the respective envelopes.
3. Technical proposals will be opened on the same day on **31 March, 2023 at 10:30 am** in presence of bidders or their authorized representatives who wish to witness the tender opening. After the technical evaluation, financial proposals of only technically qualified bidders shall be open on a date/time to be announced subsequently.
4. In order to ensure uniformity and maintenance of quality, bidders must submit their bids along with samples of all uniform articles. Bids without samples will not be received. Samples will be tested for quality assurance and standardization from any accredited government laboratory at the cost of bidder.
5. The Bid Security equal to 2% (two percent) of the Estimated Price must be attached with the **Technical Proposal** preferably in the form of Bank Guarantee or Pay Order or CDR in favor of "**Punjab Cattle Market Management & Development Company**".
6. The financial proposal shall be inclusive of all applicable taxes.
7. Affidavit on Rs.100/- e-stamp paper, duly attested by Oath Commissioner, that the company has never been blacklisted by any Government/Semi Government/autonomous body or private organization.
8. The companies/ firms/ sole proprietors must have valid Registration Certificate for Income Tax (NTN) & STRN.
9. Incomplete proposals shall not be considered.
10. The bid validity period shall be 90 days from the last date for submission of the Tender.
